If you have received a **Notice of Direct Certification** – **REDUCED PRICE** from the school district for reduced price meals, this application may be submitted. **DO** let the school know if any children in the household are not listed on the **Notice of Direct Certification**- **FREE** letter you received. Complete one application per household. Please use a pen (not a pencil).
