Hello, MERSD School Committee.

Attached please find financials for the 4/3/23 School Committee meeting consisting of:

- Accounts Payable (AP) vouchers 1053 and 1055-1057
- Payroll Vouchers for March
- Treasurer's Cash report for March

#### **AP Vouchers**

V1053 - \$660 to Centers for Medicare & Medicaid Services for payments due in April and May on behalf of legacy retirees that MERSD migrated to Medicare for health insurance after their initial eligibility.

V1054 – there is no V1054. This voucher was deleted during the AP preparation process.

V1055 - \$55.47 to MA Department of Revenue for taxes on meals purchased by adults in January and March. February taxes were paid with School Committee vouchers on 3/7/23, but the January register reports were not available to the AP department at that time.

V1056 – main AP voucher totaling \$1.005 million, of which \$786.2K is from the General Fund budget. With only one School Committee meeting in April, this voucher is larger than usual. Of note:

- Transportation:
  - \$91.9K to Salter Transportation, consisting primarily of monthly contract payments for regular day transportation for February, March and April (\$28.15K/month). This amount is down from our original contract monthly rate of \$42K due to route consolidation at the start of the year. These savings were recognized in budget reductions when the FY23 budget was first adopted, and in subsequent transfers as savings exceeded our initial estimates.
  - \$74.6K in special education transportation for budget-funded out-of-district placements in March to vendors including Action Ambulance, LBK, Nick's, Skye and VSP. Costs remain in line with our adjusted budget of \$720K, which was increased by \$37K in November.
- Athletics:
  - \$2.6K to Arbitersports, which will be the new platform for athletics registration and beginning in FY24 for payment of officials.
  - \$6.7K to Fieldturf for standard spring preventative maintenance on turf fields. Because of field investments made last summer, both fields passed their GMAX impact tests prior to the start of the current spring season. Cost is as budgeted.
- Finance:
  - \$2.5K to Hilltop Securities for annual required disclosures on our publicly traded debt

- \$4.5K to Powers & Sullivan for audit of our FY22 Department of Elementary & Secondary Education (DESE) “End-of-Year Financial Report” (EOYR). DESE requires all districts to hire an outside accounting firm to audit the annual submission to DESE in which we classify all expenditures and revenues, by funding source (e.g. budget, grant, revolving), function, and school. This data is the source for DESE public reports that compare districts across the state on per pupil expenditures and also provides the financial component for average teacher salaries. The data also is used by ClearGov, which puts EOYR spending patterns into citizen friendly charts, which we make available on the MERSD web page. Powers & Sullivan is required to submit their EOYR audit findings to DESE, and we share the report with School Committee each year. This year, MERSD had another clean audit for our EOYR submission, with no “findings.” A copy of the report will be part of our June package for School Committee, which will include the full FY22 audit and a presentation from Powers & Sullivan on their reports, process and observations. These costs are within budget.
- Curriculum/Instructional Technology
  - \$3.8K to Liminex for GoGuardian licenses at elementary and middle schools, which enables teachers to monitor student Chromebooks
  - \$2.1K to Turnitin for FY23 license of writing instructional software at HS
  - These costs were included in prior technology budget forecast and are within budget.

V1057 – Student Activity (SA) Account transfer request of \$29,207.76 from High School to replenish checking account from HS SA Savings account, for checks written between December and early March. Check detail is included in the excel documentation.

**Payroll Vouchers for March**

MERSD pays employees on a bi-weekly basis, and March is one of two months this fiscal year with three pay dates: 3/2, 3/16 and 3/30. Amounts for these payroll dates are fairly consistent at \$739.4K, \$735.2K and \$726.1K respectively. The first two paychecks of the month included closing payments for winter athletic coaches, which explains the slight dip on the third/final March payroll.

**Treasurer’s Cash Reports for March**

Treasurer’s reports are attached showing cash balances of \$13.049 million at 3/31/23. As mentioned previously, January and February balances had dipped to the \$7-9 million range, following MERSD debt service payments in those months, while awaiting repayment from member towns through FY23 Capital Budget assessments. This repayment has now occurred, as shown in the Treasurer’s monthly receipts report, which shows total inflows for the month of \$9.4 million. These inflows were offset by March AP and payroll voucher outflows. The March ending total is the highest monthly balance so far this fiscal year. Keep in mind that MERSD pays teaching staff 6 paychecks in June (regular bi-weekly on 6/8 plus 5 summer checks on the last day of school, per the agreement with the Manchester Essex Teachers Association), so cash balances will be slightly higher in March through May before dipping again.
